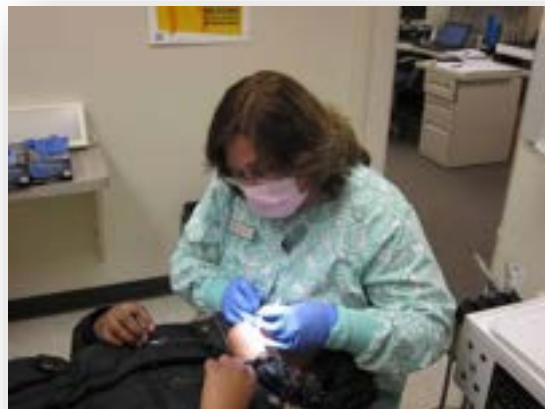

Through partnerships with Sostento and with the City of Racine, HCN has provided 2,366 COVID-19 vaccines to the Racine County community throughout the 2021-2022 fiscal year.

What's Happening Out West?

HCN's satellite-clinic, located inside the Aurora Health Center at 818 Forrest Lane in Waterford, provides medical services to patients living in western Racine County.



The Waterford location is essential for providing care to all of Racine County.

This clinic makes care accessible for those who lack transportation to the downtown Racine location, making sure that HCN patients do not fall through the health care gap. Thank you to Health Coordinator Vickie Shellberg, our incredible volunteers, and the Aurora Health Center for making this possible!

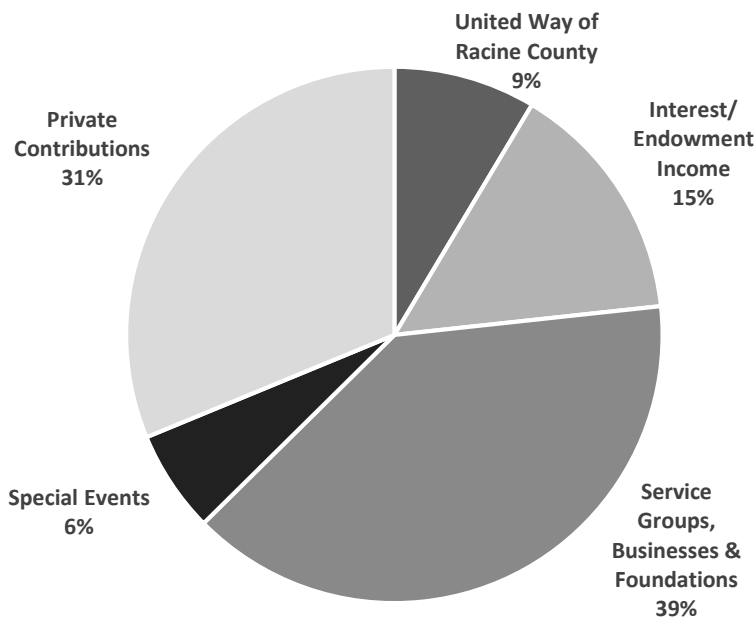

Health Care Network, Inc. Annual Report 2021-2022

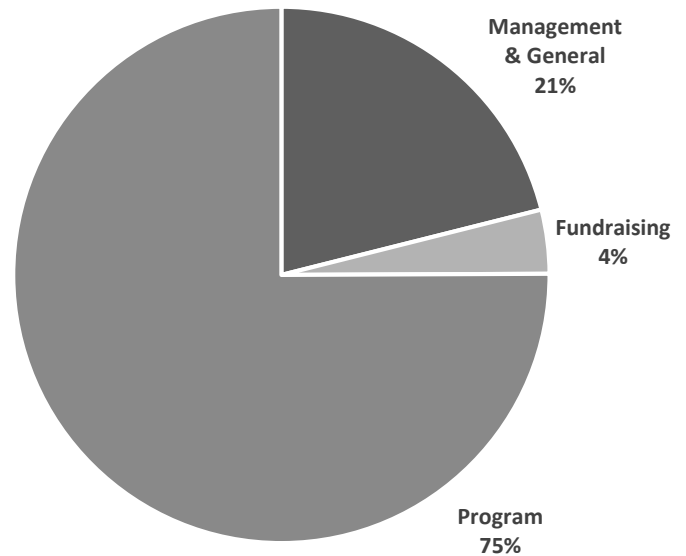
As our Racine County community continues to recover from the effects of the COVID-19 pandemic, the need for Health Care Network's safety net services is continually present. We, at Health Care Network have never been more committed to providing medical, dental, and behavioral health services to the low-income, uninsured of Racine County. Throughout the 2021-2022 fiscal year, HCN has scheduled a total of 9,886 appointments and assisted patients in obtaining 2,568 prescriptions. This care is valued at over \$2.6 million and is only possible through the endless support of our volunteers, donors, and the Racine County community.

Since its inception in 1987, Health Care Network has helped patients obtain more than 99,500 prescriptions and has scheduled over 241,500 appointments, representing a value of over \$52.6 million.

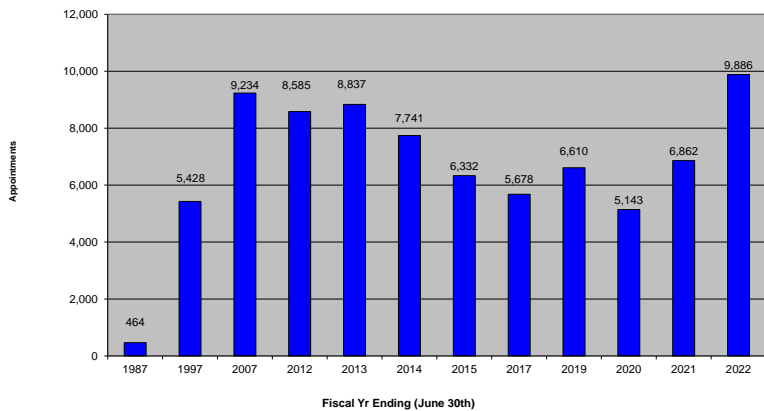
Revenue



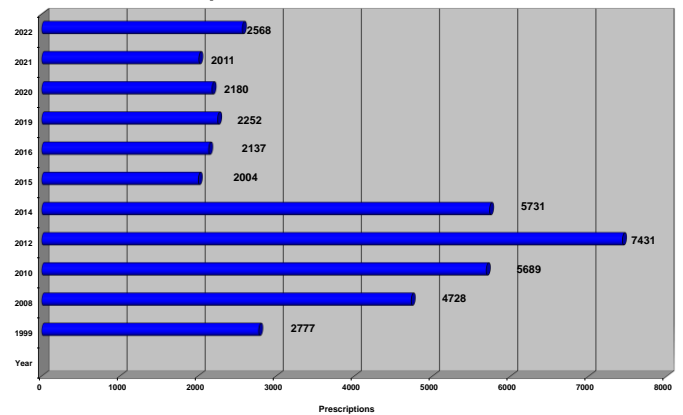
Expense

Community Impact

In addition to monitoring patient improvements, Health Care Network takes into account how its programs have improved the community at large. Our programs emphasize the integration of healthy lifestyle habits into a patient’s everyday routine and to develop measurable skills in safety and health.

72.5% of patients suffering from diabetes and hypertension maintained or improved blood pressure readings and/or fasting blood sugar/glycohemoglobin levels.

81.2% of all dental patients demonstrated acceptable prophylactic oral care as evidenced by an oral health exam.

\$5 of medical and dental services are provided for every \$1 in donations.

\$2.6 million in services and medications provided during the 2021-2022 fiscal year.

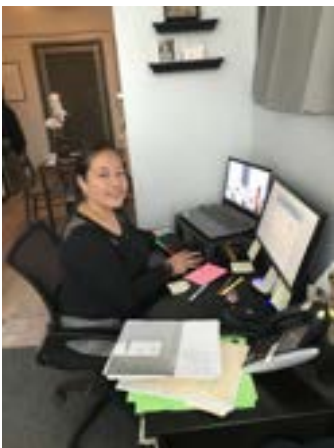

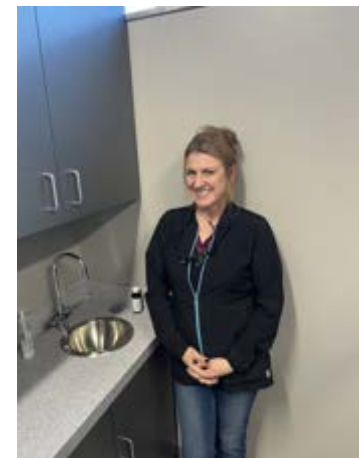
